

Minutes of the Meeting of Hillington Parish Council held on Tuesday 26 March 2019, 7.30pm in the Ffolkes, Hillington.

1. Apologies for absence and approval of reasons for absence.

2. Declarations of Interest.

The Village Sign was now up and looked very good, many thanks to Cllrs Kivlin and Worsley. Cllr Kivlin would send the photograph through to the Clerk.

The Clerk reported that the Newsletter had not issued as the Post Office had not confirmed the start date.

Cllrs Kivlin and Wallace reported on the Greenways consultation. The plan was to encourage cyclists and the idea in principle was good, but it needed to be thought through as there were houses on the line with diversions through parts of Hillington required.

A resident highlighted that the draft local plan was inaccurate as it made no reference to Tapping House either in the text or the map.

Police traffic cameras were on site in Station Road

Concern was raised about the cost of disposal of DIY waste and the implications for fly tipping.

The Clerk would enquire at both County and Borough Councils if the level of Fly tipping had increased over the past year.

A resident enquired about what was happening at the KLIC building in King's Lynn.

The Clerk had received sufficient volunteer forms and would send off the forms to the Police who would vet and then organise training.

9.2 Parish Partnership Bid

The Council noted that following the last meeting Cllr Dark had offered to support the purchase through the Parish Partnership scheme mobile speed activated signs in a scheme with Flitcham. The Clerk had submitted a bid as advised. The results of the bid were not yet known. The clerk was asked to confirm the type of data collated by the units.

9.3 A148 Pedestrian Refuge

The Council noted the report from the Highways Inspector. Safety checks had been made and there would be no further action other than replacement of damaged bollards.

Resolved to write to the Petrol Station to ensure signage does not block the visibility splay
